Following your directive, we proceeded to the workshop messes **ADEXMAN AUTOMOBILE NIG LTD** located at Games Village, Abuja where we carried out the physical inspection of the above captioned vehicle and the attached photographs are taken for your record purposes.

DESCRIPTION OF ACCIDENT

The repairer could not tell us how the accident happened. However, our physical inspection revealed that the impact of the accident damaged the under listed parts of the insured vehicle.

Damaged parts of the insured vehicle captioned above are listed below:

Rear bumper
Front bumper
Front down grill
Rear light LHS

Radiator fan clutch and blade
Front indicating light

ESTIMATED COST OF REPAIRS

The insured's workshop forwarded a total estimate of **N1,058,000.00** and the same was vigorously compared to the extent of damaged. Our physical inspection confirmed that the estimate was realistic in parts but inflated in prices. We discussed with the workshop manager and called his attention to the prices quoted for each item, we told him that the estimate is on the high side and we made him to understand that it will be adjusted. But he refused initially. But at the end of our discussion with him, he allowed a total reduction of **N228,000.00** from the estimate.
