Following your directive, we traveled to KADUNA STATE and called at the workshop premises **Messrs DELE MECH AND MOTORS NIG. ENT.** located at Sabo Tasha, Kaduna, Kaduna State where we carried out the physical inspection of the above captioned vehicle and the attached photographs are taken and attached for your record purposes.

DESCRIPTION OF ACCIDENT

The workshop manager could not tell us how the accident happened. However, our physical inspection confirmed that the impact of the accident damaged the under listed parts of the vehicle:

Front bumper
 Fog light with cover
 Reservoir engine
 Reservoir container
 Side mirror
 Fog light seat

REPAIR ESTIMATE

The repair estimate cost to the tune of **N800,000.00** forwarded by the workshop mentioned above was thoroughly examined and compared with the extent of damaged done on the vehicle and we observed that the estimate was inflated in prices but realistic in parts. We therefore discussed with the workshop manager and called his attention to the prices quoted for each item, we frankly told him that they are on the high side and they are subject to adjustment. We logically backed our argument with the current auto parts prices. We contacted the Oriapata auto spare parts market located at Kaduna and based on the prices obtained the estimate is adjusted but he was not satisfy with our adjustment claiming that the parts in the open market could be inferior due to the newness of the vehicle but we confirmed the genuineness of the prices of the parts given to us. Several amendments were made before he allowed a total reduction of **N180,000.00** from the total estimate.
